



1. Compulsory Identification

- The driver should be in possession of a driver's license for a minimum of 1 year.
- The additional driver must be present when collecting the rental car and must have a valid driver license.
- All drivers (renter/additional driver) must be registered with R&R Car Rental for the car and passengers to receive coverage.

2. Minimum age

- The required age is 23 years old.
- The minimum age is 19 years. If you are between the ages of 19 and 22 the required deposit will be ANG 650.00 / USD\$ 371,42

3. Rental car

- The rental price is inclusive (9%) tax.
- The rental price is based on 24-hour rental day starting at the time of rental (pickup), for each extra hour the USD\$10 will be charged up to the applicable daily rate.
- The deposit is USD\$ 371.42/ ANG 650.00(23 years and older)
- The rental price is exclusive gasoline costs, If at the end of the rental period the gasoline is less than on the day of delivery an additional cost of ANG25,- per quarter will be applied.

4. Exclusion

The rented vehicle shall not be used to:

- Be operated by any other person/s other than those stipulated by the renter (max.2) without the written permission of the Owner. **If the Renter allows any other driver to drive the rented vehicle, the Owner/Lessor can remove the car immediately from the renter's possession without any refund.**
- By a person who is not in possession of a valid driver's license, whose correct name and address is not mentioned on the rental agreement, or in respect of whom an incorrect name, address or age has been indicated.
- For the transport of passengers or goods for a fee, for a purpose contrary to the law (such as theft, smuggling, etc.) in speed tests, for giving driving instruction, competitions or rallies or for pushing or towing another vehicle and/or trailer.
- The renter undertakes not to overload the vehicle with passengers, luggage, cargo, etc.
- Operate the vehicle in a negligent manner.
- Drive In forbidden roads, redlights
- On unpaved roads: **by San Juan, Sheteboka, Hato caves.**
- **Be rented out to other persons**
- Carry passengers or property for hire.
- Carry passengers other than in the interior or cab of the vehicle.
- To push, propel or tow another vehicle, trailer or any other object.
- For any race or in any competition.
- **It is forbidden to smoke and have pet(s) in the car both offenses will be charged a detailing fee of ANG250,-. This fee includes the removal of pet hair and deodorizing the car of the smoke scent.**
- For any illegal purposes.
- The Renter has no right to drive the car intoxicated or after consuming any narcotics.

5. Responsibility

- The car has to be locked and with the alarm on when not in use.
- The steering lock needs to be used at all times
- The car needs to be parked in a secured area (behind a fence) at night. If not, the car will be towed away and all costs for the renter.
- Returning the rental in any of the conditions listed below will result in a fee being applied for a detailed cleaning of the car, excessively dirty condition that requires extra cleaning or deodorizing. This includes, but is not limited to, spillage of fluids, food, and vomit, other stains, and unpleasant odors including cigarette smoke.
- A flat tire must be made by the tenant at his expense at a "tire-repair shop" (Naf 10.00) These can be found in various places along the road. If the car is returned with a flat (spare) tire, Naf 350.00 will be charged. If a tire cannot be repaired, the tenant must have a new tire applied at his own expense and inform the landlord immediately of this in time of the occurrence of the damage.
- It is NOT permitted to jump start anyone else's car.
- The windows/windcreens are on the responsibility of the renter in case of breakage, it is important not to leave any valuables in the car e.g.(bags, sunglasses, watches)
- During the rental period, the renter is responsible for all cost involved in traffic violations and parking fees.
- With misplacement and or water damage of an electronic key USD\$300 , Chipped key USD\$250 or normal key USD\$ 50,- the mentioned fees will be charged.
- Any damages and or broken fragments of the key fob (key accessories) a USD\$ 25 fee will be charged.
- **Renter is responsible to fuel the tank with Unleaded gasoline (SUPER/Yellow handle) if failed to do so the repair fee is for the renter.**

6. Loss of personal belongings

- The owner is not responsible for any damages to or loss of own property that the renter has left in the vehicle.
- The renter must prevent any right to the vehicle from being established, that it is lent or sold or that it is otherwise available.
- Any nullity or invalidity of one or more provisions of this agreement shall not affect the validity and applicability of the others. Any costs resulting from the non-compliance with these conditions are entirely at the expense of the tenant.

7. Accident

It is mandatory for the renter to:

- Inform R&R Car Rental by accident or any damages to the car
- To call CRS(199/ +599 97471333) and police department(911) if needed Ambulance (912)
- Do NOT move the car from place of the damage/accident

8. When damage has arisen due to irresponsible driving behaviour, intentional acts or omissions, recklessness, gross negligence or gross negligence on the part of the renter due to intent (including if the driver has caused a collision and /or accident under the influence of alcohol and / or drugs), the entire damage will be recovered from the renter.

PERSONAL ACCIDENT INSURANCE

Personal Accident Insurance is included in the rent of a vehicle.

This option covers the authorized drivers and passengers.

Please see below for a brief summary of cover:

Accidental death ANG 10.000,00

Disability ANG 50.000,00

COLLISION DAMAGE WAIVER (INCLUDED)

Collision Damage Waiver reduces the renter's liability from the total cost of the damage to an excess amount, where applicable, unless the renter intentionally causes the damage, is under the influence of drink or drugs, or uses the car in a prohibited(forbidden signs,redlights) or negligent way – such as driving off main roads or hiring to other parties and if the vehicle is not used in accordance with the terms and conditions of the rental agreement. CDW covers liability for damage to the car or its parts. Windscreens, tires, undercarriage, replacement locks, replacement keys and towing charges are not covered under the CDW policy.

THEFT PROTECTION

Theft Protection (TP) is not insurance. The TP reduces your financial liability for theft to the rented vehicle, its parts and accessories, if the vehicle is used in accordance with the terms and conditions of the rental agreement. TP does not cover damage to tires nor personal belongings. If the car is NOT used in accordance with any of the terms of the rental agreement the renter is responsible for the full cost of theft to parts and or value of the vehicle.

Collision damage waiver and Theft protection ("CDW-TP"): The rental vehicle is covered in addition. R&R Car Rental will agree to waive the renter's responsibility for loss or damages to the vehicle in part (depending on the cause of the damage). Does not apply if:

- (1) the renter uses the vehicle in violation of the rental agreement;
- (2) the renter fails to remove the keys, or close and lock all windows, doors and trunk, and the vehicle is stolen or vandalized;
- (3) the driver was under the influence of drugs or alcohol at the time;
- (4) the driver was determined to be negligent;
- (5) the insured vehicle was moved prior to police instruction;
- (6) the vehicle was being used off-road;
- (7) the renter fails to notify R&R Car Rental, Forensys Curacao (199) and police immediately after the loss; and
- (8) The renter fails to pay the charges under the rental agreement

The car is W.A. and Casco insured(Allrisk). Costs to the rental car, resulting from an accident, collision, theft, burglary or vandalism becomes a deductible of resp. Euro 500.00 for damage and Euro 250.00 for civil liability damages (this deductible applies per claim) recovered from the renter, who indemnifies the lessor in this respect, remains damage to third parties, which although compensated by the insurer on the basis of the law, but in respect of which under the policy conditions is not coverage. This occurs if the driver has been under the influence of alcohol or drugs at the time of the occurrence of the damage, this damage will be fully recovered from the renter.

The law of the country Curacao applies to the rental agreement and any resulting agreements. Disputes arising from these terms and conditions and/or rights and obligations of those involved in agreements to which these terms and conditions apply will only be settled by the competent court in Willemstad (Curacao) and in urgent cases the President of the Court in Willemstad. Conditions are available for inspection by the landlord and in the rental
